Municipal Incorporation



Becoming an incorporated entity has numerous advantages but also carries various responsibilities. In Georgia, municipal corporations (regardless of geographic size or population), are responsible for complying with a host of administrative, reporting, and record-keeping laws including those related to comprehensive planning, solid waste, management planning, financial management, ethics, open meetings/open records, and election laws. These laws need to be understood by residents of the area interested in incorporation because once the charter is granted, one (or more) qualified administrative staff person(s) must be able to take over the record-keeping requirements.



General Fund Proposed FY 2025 Revenue



General Fund Proposed FY 2025 Tax Revenue by Type





General Fund Proposed FY 2025 Millage Rate

- FY2025 Property Tax revenue is based on a 1.207 millage rate valued at \$61,609 (value of 1 mill is \$51,044).
- I propose leaving the millage rate at 1.207 mills due to the forecasted LOST revenue.
- Revenues for Insurance Tax Premiums and Ad Valorem have been budgeted slightly higher than in FY2024.





Inflation may have slowed, but prices have not gone down.....



- Since the start of the pandemic, Americans have seen average prices increase more than 20% overall giving people a sense that the cost of many goods and services, not to mention housing, has surged to unreasonable levels. - Consumer prices were up 3.4% for the 12 months ended in April, easing from 3.5% the month before, according to the latest Consumer Price Index report released Wednesday by the Bureau of Labor Statistics. Chart 1. Over-the-year percent change in CPI-U, Atlanta-Sandy Springs-Roswell, GA, February 2021-February 2024




Chart 1. Over-the-year percent change in CPI-U, South region, March 2021-March 2024

General Fund & SPLOST FY2025 Expenses



- Utility, computer subscriptions, cost of goods, and services have been budgeted with 2% to 5% increases aimed at covering continued price increases. Property and liability insurance, on the other hand, is budgeted 14.5% higher than FY2024 due to the actual increase the Town received in May for the 2024-2025 premium.
- Capital Improvements
 - Hardy Hall Roof Repair or Replace
- SPLOST Projects
 - 2017 SPLOST
 - Engineering for the 85 Connector / Brooks Rd. Proposed Round About
 - 2023 SPLOST
 - Library Upgrades—This evening, quotes for repairs and upgrades to the library are being proposed for approval. These include mold removal, repair, and upgrade of the drainage to the library's back wall, tar, and glaze-damaged bricks as needed to eliminate future erosion and mold.
 - Cemetery Expansion—As part of the cemetery expansion, a survey will be conducted to provide new lots for purchase.

FY2025 Proposed Project & Program Funds Allocated Out of General Fund

- \$15,000 Capital Improvement Projects
 - Hardy Hall Roof Repair or Replace
 - Emergency repairs as needed
- \$12,000 Stormwater Program
 - Funds for Stormwater System Inspections and Maintenance
- \$12,000 Brooks Area Recreation
 - Funds for programming and operations
 - Provides physical activity and sportsmanship for the youth of our town and surrounding area
- \$1,200 Brooks Woman's Club
 - Santa in December at the Brooks Market, cleaning the Chapel every other month, and promoting the Town of Brooks



FY2025 – ARPA

ARPA – "American Rescue Plan Act" was signed into law on March 21, 2021, due to COVID-19

ARPA funds can be used to respond to natural disasters, build critical infrastructure, support community development, and invest in water, sewer, and broadband infrastructure.

All ARPA funds must be spent by 12/31/2026

Projects to utilize the available funds of \$99,965:

- McIntosh Rd / Hwy 85 Connector Pedestrian Crossing
- Installation of surface parking along Church Alley


FY2024 vs FY2025



- FY2025 revenue and expense proposed budget reflect a 5.9% increase vs. FY2024 revenue and expense budget (COLA increase not included)
- LOST revenue proposed budget increased by \$27,500 (\$142,500 to \$170,000)
- Utilities, computer subscriptions, and cost of goods and services reflect an increase from 2% to 5%, and property & liability insurance a 14.5% increase compared to FY2024
- The revenue opportunity for cemetery plots is limited until a new section of the cemetery becomes available. As of May 2024, revenue for cemetery lots for FY2024 has exceeded the budget by \$45K

Cost of Living Adjustment for Staff

- Social Security implemented a 3.2% Benefit Increase for 2024, aka Cost of Living Adjustment (COLA).
- During the May 20, 2024, FY2025 Budget presentation, the Mayor and Council were asked to consider a 3% COLA for the town staff, as inflation has affected the Town's expenses and employees.
- During the May 20, 2024, Council Meeting under New Business, a motion was made to implement a 4% COLA for all staff employees. The motion passed unanimously. The council and mayor are not classified as staff employees.
- The approved 4% COLA cost is \$8,200 and will be funded using the fund balance.
