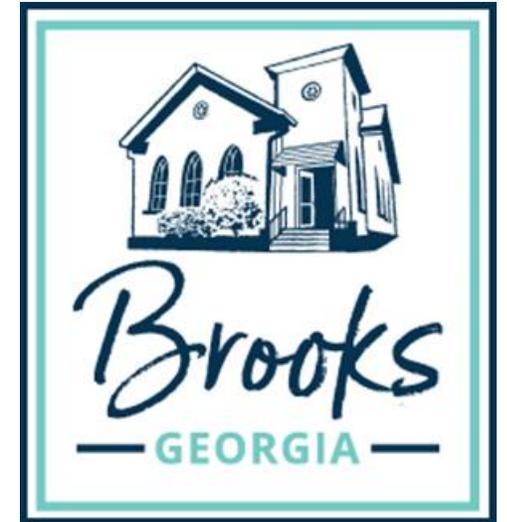

Purpose of Amending the Approved FY2025 Amended Budget

During the audit of the fiscal year ended June 30, 2025 (FY2025), it was noted that adjustments were required to General Government and Public Works expenditures to ensure they reflected actual costs incurred during FY2025.

Certain expenditures were paid/recorded after the fiscal year-end; however, the related projects and underlying obligations pertained to FY2025. The expenditures were primarily associated with the Hwy 85 Connector and W. McIntosh Road improvement projects.

As a result, audit adjustments are being proposed to properly recognize these expenditures in the appropriate fiscal period.

As a result of these adjustments, the General Fund balance was also affected, with an additional \$38,485 recognized as fund balance used for FY2025.

General Fund Unrestricted Fund Balance FY2025

The unaudited fund balance presented in the Amended FY2025 Budget in December 2025 was subsequently adjusted during the FY2025 audit to reflect revisions to FY2025 expenditures. These adjustments resulted in a corresponding change to the reported fund balance to ensure consistency with the final audited financial results.
